

OFFICIAL RULES STORYSHARES 2025 FALL INTO FICTION SHORT STORY CONTEST

THIS IS A PROMOTIONAL CONTEST. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. The Promotion is void where prohibited or restricted by applicable law, and all applicable federal, state and local laws and regulations apply. Winners are responsible for any taxes, customs, duties and like amounts connected with the prizes.

1. **How to Enter.** To participate in the 2025 Fall into Fiction Short Story Contest ("**Promotion**") for a chance to win prizes, eligible persons ("**Contestants**") must fill out an online registration form and submit a Qualifying Story ("**Registration**") at <https://www.storyshares.org> ("**Promotion Site**") between 12:00 a.m. (midnight) Eastern Time on September 22, 2025 and 11:59 p.m. Eastern Time on November 21, 2025 (the "**Entry Period**"). The submission of Registrations shall be subject to the Sponsor's Privacy Policy.
2. **Eligibility.** Eligibility to participate in the Promotion or to win prizes is open to individual persons who are legal residents of the United States or its territories and possessions. Individuals who reside in *most* countries other than the United States are also welcome to enter the contest; however, all stories and passages must be submitted in English. **Entry in the competition is void where prohibited by law.** Individuals residing in Brazil, Italy, The Netherlands, Russia, and Quebec are not eligible to participate. Limit one (1) Registration and submission per registrant or individual. Any effort by an entrant to misrepresent himself or herself through the use of aliases or multiple e-mail addresses will disqualify that entrant. Entrants who disregard these Official Rules are not eligible to participate or win. Directors, officers, employees, contractors, and agents (and their immediate families and household members) of the Sponsor, its parents, affiliates, subsidiaries, advertising and promotion agencies, or any other company involved with the design, production, execution, or distribution of the Promotion are also not eligible. The Sponsor's determination of eligibility, in its sole discretion, shall be final.
3. **Submissions.** As part of the Registration, registered users must submit a story or passage ("**Qualifying Submission**") under one of the following prompts: i) What if a single object suddenly consumes your attention -- and changes everything? Write about someone who gets caught up in a mysterious or irresistible item, and explore how that distraction pulls them into trouble, discovery, or a new way of seeing the world. ii) Opposites attract... or clash? Create a story about two teens who couldn't be more different but must team up for a project, job, or family task. Dive into their clashes, frustrations, and how their differences might just be the key to success. ("**Prompts**"). Each Qualifying Submission shall be uploaded and submitted through the website, according to the guidelines and word limits for the contest. More specific information about the contest and the content for each story is located at <https://www.storyshares.org/contest/>. By uploading your submission, you agree that it conforms to the Guidelines and Restrictions as defined below and that the Sponsor may disqualify you from the Contest if it believes, in its sole discretion, that your Submission fails to conform to these Guidelines and Restrictions.

The guidelines and grant of rights to each of the award categories are as follows:

Guidelines: Registered users must submit a story between 1,000 and 2,000 words ("**Qualifying Story**") under one of the following prompts: i) What if a single object suddenly consumes your attention -- and changes everything? Write about someone who gets caught up in a mysterious or irresistible item, and explore how that distraction pulls them into trouble, discovery, or a new way of seeing the world. ii) Opposites attract... or clash? Create a story about two teens who couldn't be more different but must team up for a project, job, or family task. Dive into their clashes, frustrations, and how their differences might just be the key to success. ("**Prompts**"). Each Qualifying Story shall be submitted either as a Word document or a Google document through the writing platform found at "<https://storyshares.org/contest/>" with an overall

length of fewer than 2,000 words. More specific information about the contest and the content for each submission is located at <https://storyshares.org/contest/>.

Rights: By completing a Registration, Contestant grants to Sponsor, its agents and others working on their behalf a royalty-free, irrevocable, perpetual, non-exclusive right and license to use the Registration and any related Qualifying Story for advertising and marketing purposes, including on the Promotion Site, without additional compensation, unless otherwise prohibited by law. This includes, without limitation, the right to copy, distribute, reproduce, modify, edit, publish, transmit, translate, reformat, create derivative works from, display, perform, and otherwise use such materials in whole or in part, on a worldwide basis; to incorporate such materials into other works, in any form, media or technology now known or later developed, including for promotional or marketing purposes; to publish your name in connection with your Qualifying Story and the right to sublicense such rights. Should a Qualifying Story be selected for publication, additional rights may be granted to Sponsor, to be confirmed in writing at time of selection.

4. **Judge.** Each Qualifying Submission will be reviewed by a panel of at least four judges (“Judges”) to determine which of the Qualifying Submissions receives the highest score in each division based on the criteria set forth [on the appropriate guidelines/rubric link on the Storyshares contest website](#). (“**Best Qualifying Submission**”). The Judges’ determination of the Best Qualifying Submission in their sole discretion in accordance with these Official Rules, shall be final.

5. **Prizes.** The Contestant submitting the Best Qualifying Story as chosen by the Judges will receive a Prize as follows:

11th - 12th Grade Winner	\$250

6. **Additional Submissions.** In the event there are more than one Contestant who have received identical scores by the Judge for a Best Qualifying Story in the same Category, a Contestant may be asked to submit an additional Qualifying Story to be evaluated by the Judge using the same criteria as the original Qualifying Story. The Contestant having the highest score amongst the additional Qualifying Stories will be deemed to have the Best Qualifying Story for that Category.

7. **Conditions of Participation.** Each Contestant agrees to be bound by these Official Rules and all decisions of the Sponsor and Judge, whose decisions will be final. The Sponsor is not responsible for any printing errors in these Official Rules. In addition, each Contestant that submits a Registration represents and warrants that all information contained in his/her Registration is true and accurate. The Contestant further represents and warrants that any Qualifying Story that they submit as part of the Promotion is owned or controlled by the Contestant without violation of any third party’s rights.

8. **Winner Notification.** The winners of the prizes will be notified by e-mail. Sponsor may require a prize winner to execute an affidavit of eligibility, publicity release (except where prohibited), liability waiver and/or IRS Form W-9 (if required by IRS regulations) prior to the delivery of any prize (collectively, “**Affidavit**”). If the prize winner does not respond to the notification within thirty days, is found to be ineligible, fails to execute the Affidavit or other documentation required by Sponsor, the Sponsor may consider such prize winner to have forfeited their prize, and another prize winner may be selected. Sponsor makes no warranties with regard to the prizes. The prizes are not transferable and the winner has no right of substitution.

9. Announcement of Winners. The names of the prize winners will be posted on or before January 5, 2026, for at least 30 days after the end of the Entry Period at the Promotion Site.
